

On September 11th, 2001, the Twin Towers of the World Trade Center were struck by airplanes, but their collapse was caused by explosives.

This fact can be scientifically proven, but our news agencies refuse to tell this to the public. We were told burning jet fuel caused the collapse, but that's impossible.

Please consider this:

- *Debris ejected 100 meters away from the towers could not have been propelled by a gravitational collapse.*
- *No steel skyscraper has ever collapsed as a result of fire, although some have burned much longer.*

The World Trade Center was destroyed by explosives, not airplanes. Who could have done this?
